The regular meeting of the County Commissioners of Allegany County was held in the Commissioners' Meeting Room, Allegany Room 100, 701 Kelly Road, Cumberland, at 05:01 PM on 5/11/2023. Caporale, County Administrator Jason Bennett, County Attorney Lee Beeman.

3. Approval of Agenda

4. Approval of Previous Meetings Minutes

Upon Motion made by County Commissioner Creade V. Brodie, Jr., seconded by County Commissioner William R. Atkinson, and duly carried, the Minutes from the previous public business meeting were approved by the Board of County Commissioners.

5. Presentations

A. Citation, BSI honored with MEDA Award - **Gene Silverman (BSI) and Adam Strott (ACDECD)**

Berkeley Springs Instruments (BSI) was recently presented with the Small Community Economic Development Project award from the Maryland Economic Development Association (MEDA.) Representing a public/private partnership, Allegany County played a crucial role in developing, financing, and constructing a new headquarters for BSI as they sought to expand. The Allegany County Commissioners presented business owner, Gene Silverman, with an official citation to commemorate this award.

B. Citation, Allegany County Teacher of the Year - **Dr. Joseph Thompson, Ft. Hill High School**

Dr. Joe Thompson of Fort Hill High School has been named the 2023 Allegany County Teacher of the year. The Allegany County Commissioners presented him with a citation to honor this achievement. President Caporale also acknowledged our local teachers for Teacher Appreciation Week.

A. Appalachian Regional Commission (ARC) Federal FY 2024 Priorities- **David Nedved**

Allegany County department of Economic & Community Development employee, David Nedved, presented the prioritization list for the Appalachian Regional Commission (ARC) projects to be considered by Tri-County Council for Western Maryland as part of Maryland's Strategy Statement document for Federal Fiscal Year 2024. B. Lease of Cargo Van for Allegany County Animal Shelter - **Adam Patterson, Director of Public Works**

E. FY 23 Budget Amendments - **Jason Bennett, County Administrator**

County Administrator Jason Bennett requested approval of five budget amendments for FY 23 totaling \$26,961,697. Of this amount, \$20,000,000 is needed to recognize an increase in income tax revenues due to a large on-time increase in taxable lottery winnings, recognize \$1.1 million dollar increase in railroad/utility personal property taxes received, recognize \$193,552 in spending for vacation buy-back program, \$577,508 spending for increased election costs and \$5,090,637 of American Rescue Plan grant spending. The agreement allows for up to \$78,000 for hauling and disposal with an additional reimbursement of \$2,500 for labor associated to be funded through MES.
