Land Use Permits Issued by Type of Use for 2021



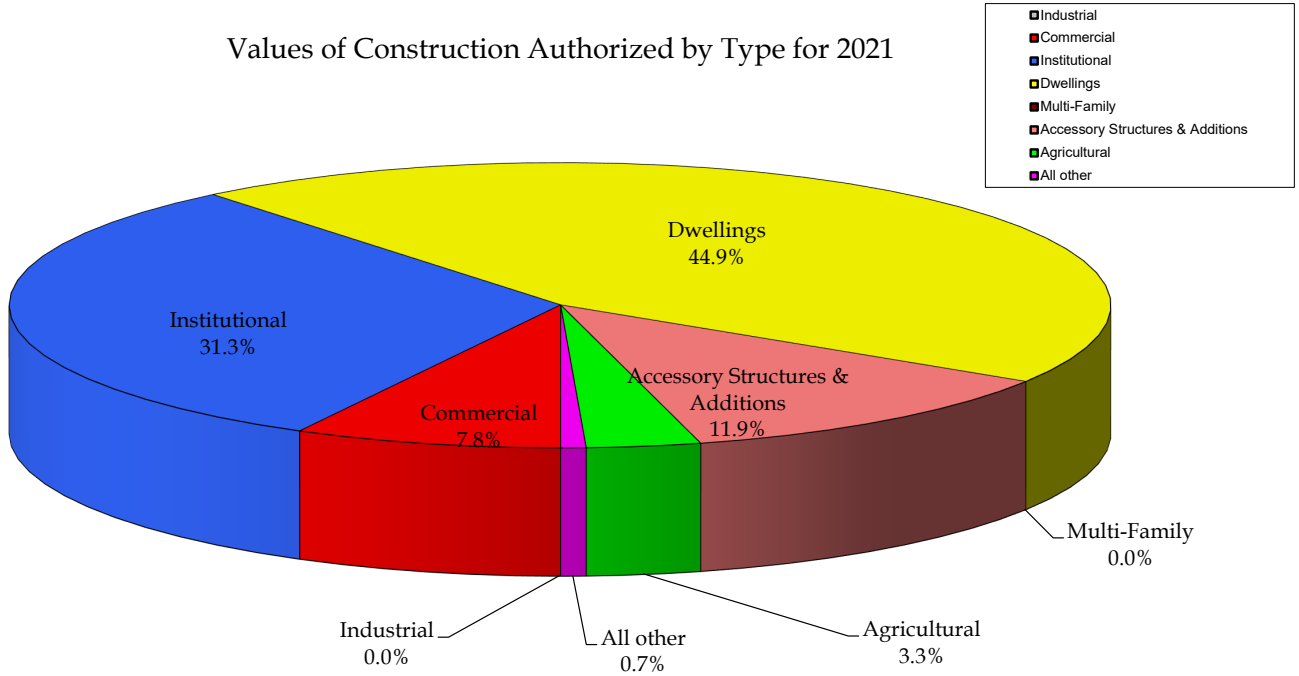

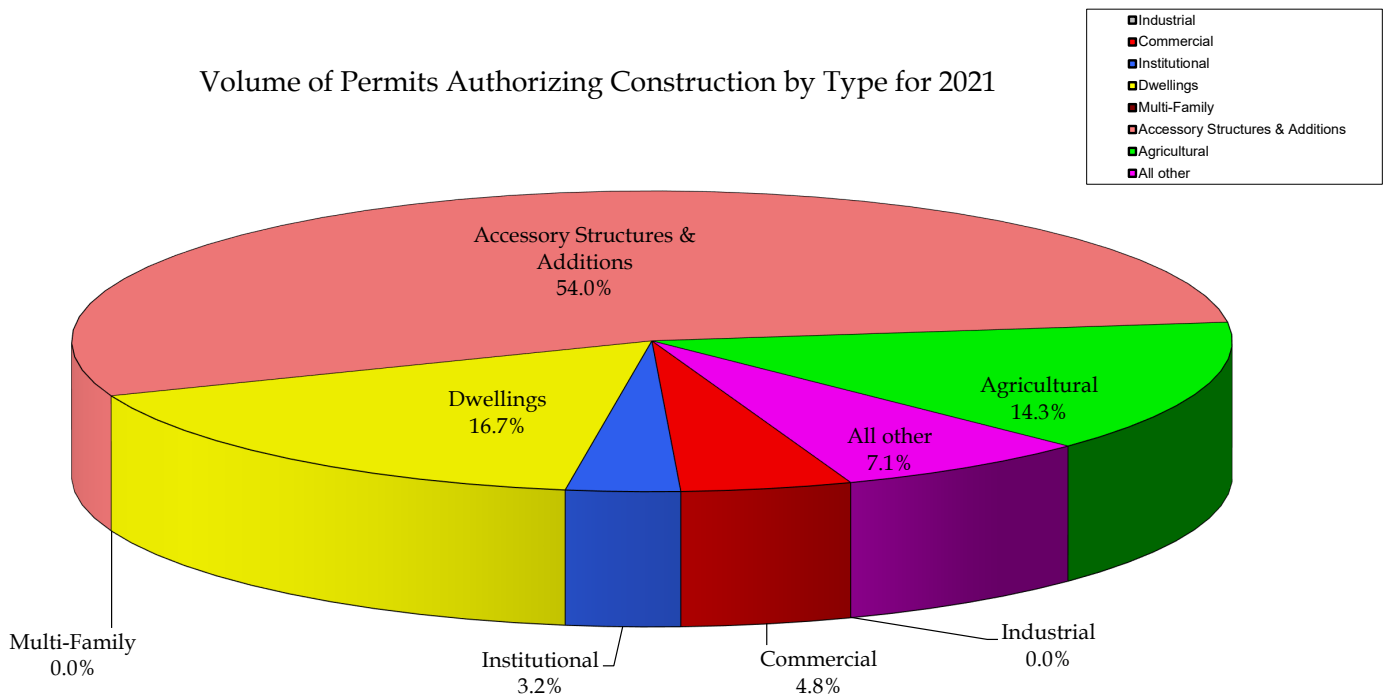

Volume of Permits Authorizing Construction by Type for 2021

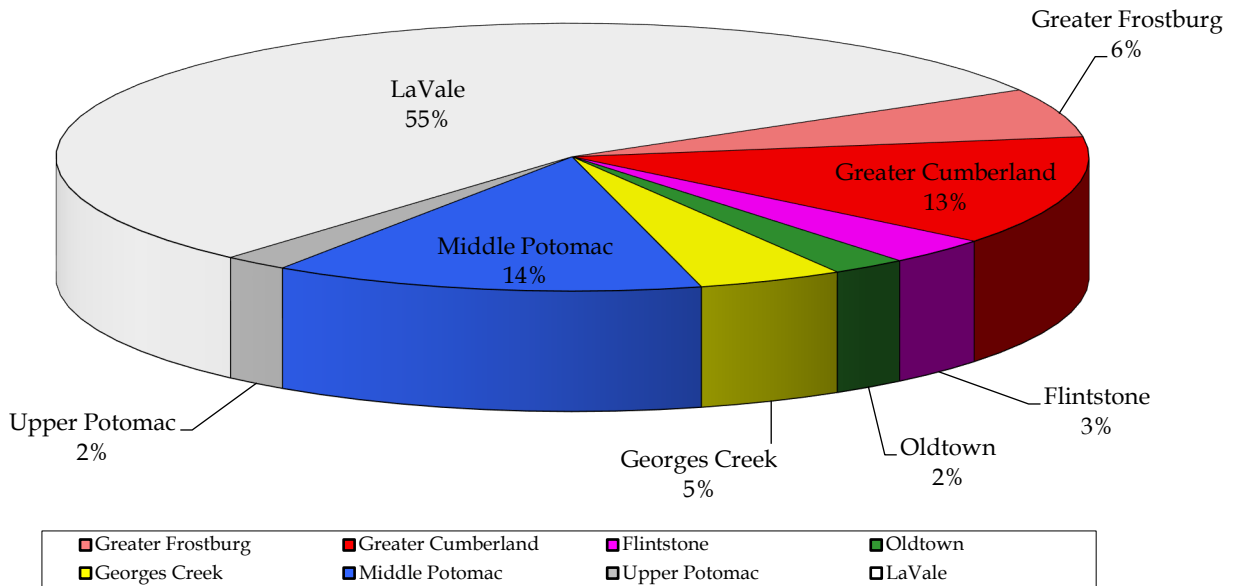

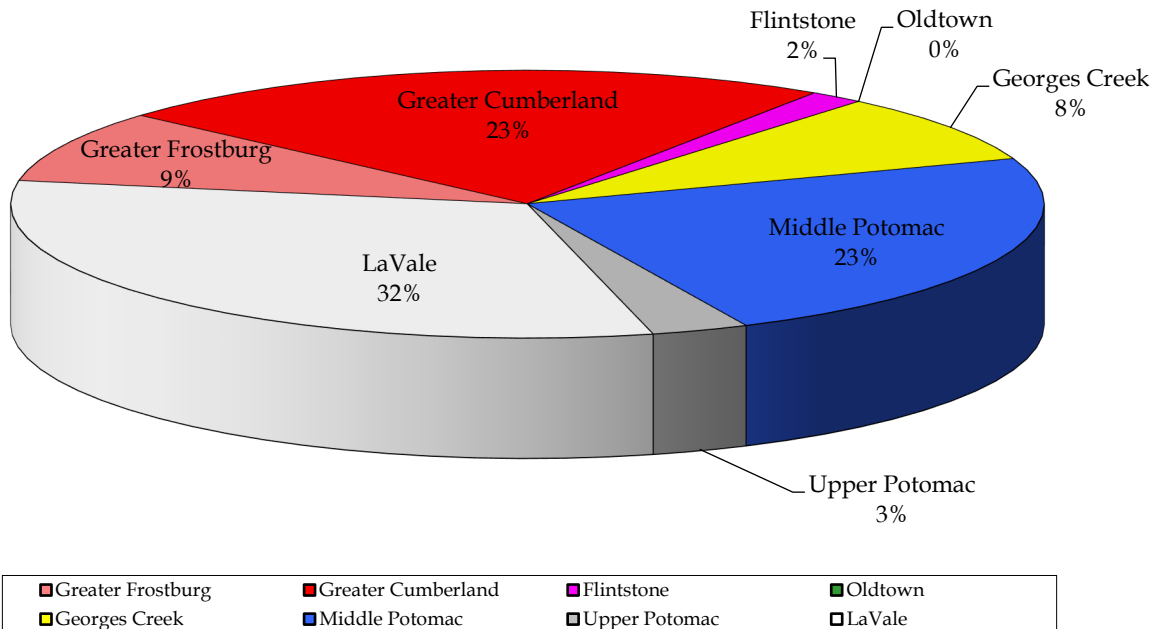
Total Values of Authorized Construction by Planning Region - CY 2021
