

Executive Summary for Allegany County Paper Gaming Office for Fiscal Year 2024

History

The Allegany County Gaming Office was created in 2003 as a self-support unit Responsible to the Finance Office of the Allegany County Government. The Authority to operate the Paper Gaming Officer and to guide its function can be found in Art. 27 of the Annotated Code of Maryland and adopted pursuant to the code of Public Local Laws of Allegany County. Our mission is to administer paper gaming activities within the county and to collect prescribed taxes from proceeds for allocation to the Education and Fire and Rescue Unit.

Fiscal Year 2024

This presentation only depicts revenues and trends for the past three years. The budget revenue projection for this year is identified below. One issue that plagues many Clubs, Convenience Stores, and Taverns is the lack of sufficient labor to maintain hours. Many operators have reduced hours of operation which in turn affected the sales of paper gaming. Also, with the current recession, it has appeared to have impacted the disposable income which led to a lack of patronages. Overall we have had another great year.

Convenience Store Operator Revenues were down (\$13,387) for a decrease of 36% ending with a total of \$23,429 for the year.

Club Revenues were down (\$4,840) for a decrease of 2.5% ending with a total of \$189,901 for the year.


Tavern Revenues were up \$10,196 for an increase of 5.6% with a total of \$193,887 for the year.

Liquor Store Revenues were up \$6,868 for an increase of 10.5% ending with a total of \$72,128 for the year.


Temporary Operator Revenues were up \$3,061 for an increase of 267.5% with a total of \$4,205 for the year.

Allocation for Education is \$216,572 for an increase of \$20,019 an increase of 10.2% and 26 Volunteer Fire Units will be allocated a shared sum of \$72,191 for the year.


Allegany County Paper Gaming Fund Revenues by Type Fiscal Year 2024




Allegany County Paper Gaming Fund Tax Revenues By Month - FY 24 Versus FY 23








Allegany County Paper Games Distribution of Gaming Stickers - Fiscal Years 2021 - 2024




Allegany County Paper Gaming Fund

Fiscal Years 2021 - 2024




Paper Gaming Fund Tax Revenues By Month Fiscal Year 2024




Allegany County Paper Gaming Wholesaler Fiscal Year 2024




Allegany County Paper Gaming Operators Licenses By Type





Fiscal Years 2022 - 2024




Tax Revenues By Allegany County Paper Gaming Operator Type

Allegany County Paper Gaming Operator Type License % Versus Revenue % Fiscal Year 2024




Allegany County Paper Gaming Operator Tax Revenues

Fiscal Year 2024




Allegany County Paper Gaming Operator Tax Revenues

Fiscal Years 2022 - 2024




Allegany County Paper Gaming Operator Tax Revenues

Fiscal Years 2022 - 2024




Revenues By Allegany County Paper Gaming Operator Top 20 For Fiscal Year 2024




Net Income By Allegany County Paper Gaming Operator Top 20 For Fiscal Year 2024



Tax Revenues By Allegany County Paper Gaming Operator Top 20 For Fiscal Year 2024




Allegany County Paper Gaming Operator Revenues

Distribution of Operator Gaming Revenues* Fiscal Year 2024





Distribution of Club Revenues* Fiscal Year 2024





Distribution of Tavern Revenues* Fiscal Year 2024



Distribution of Tavern Revenues*




Distribution of Liquor Store Revenues* Fiscal Year 2024


Distribution of Liquor Store Revenues* Fiscal Years 2022 - 2024


Distribution of Convenience Store Revenues* Fiscal Year 2024


Distribution of Convenience Store Revenues* Fiscal Year 2024


Distribution of Temporary Operator Revenues* Fiscal Year 2024






Allegany County Paper Gaming Fund Distribution Fiscal Years 2021 - 2024




Education Allocations From the Paper Gaming Fund Fiscal Year 2004 - 2024



Fire Allocations From the Paper Gaming Fund Fiscal Years 2021 - 2024




Expenses For Allegany County Gaming Office Fiscal Years 2021 - 2024




Projected Allegany County Gaming Fund Revenues Fiscal Year 2025




Projected Expenses For Allegany County Gaming Office Fiscal Years 2024
