Wholesaler's Paper Gaming License Application Procedure

The Laws/Ordinances/Regulations/Procedures reproduced here are for public convenience. These documents are not to be considered the official text of the law. Please contact the Gaming Office for official document copies.

This is an application for a license to sell paper gaming packets as defined by Chapter 132 of the Code of Public Local Laws for Allegany County, Maryland, pursuant to authority granted by Section 13-201 et seq of the Criminal Law Article of the Annotated Code of Maryland Annotated Code of Maryland.

Before this application will be processed, the applicant (or other person where indicated) must:

- Fill out the application completely. **Any missing items will prevent the application from being processed.**
- Attach a PAPER GAMING LICENSE APPLICATION PRIOR RECORD AFFIDAVIT for the applicant, if applicant is a sole proprietorship; for each partner, if the applicant is a partnership; or for each officer, if the applicant is a corporation, unincorporated association, or other legal entity.
- Submit the \$1,000.00 license fee to the Gaming Office. Make check payable to "Allegany County Commissioners".
- Attach an enlarged copy of the driver's license for the applicant, if applicant is a sole proprietorship; for each partner, if the applicant is a partnership; or for each officer, if the applicant is a corporation, unincorporated association, or other legal entity.
- If subject to tax, attach copy of paid tax bill for the current fiscal year or certification from the State, County, and municipality (as applicable) that all real and personal property taxes (including current fiscal year) have been paid.
- Attach a surety bond in the amount of \$10,000 pursuant to the Allegany County Rules and Regulations payable to the "Allegany County Commissioners" the form attached hereto.
- Attach a completed and signed WHOLESALER'S PAPER GAMING LICENSE APPLICATION Statement.
- Attach a copy of your business license.
- Submit to fingerprinting, at County Commissioners' discretion, as outlined in the Allegany County Rules and Regulations. (All fingerprinting shall be at the discretion and under the supervision of the Gaming Office.)
- Stamp fee will be applied on gaming products.
- Out-of-County wholesale vendors must have a resident agent on their license.
- Corporations, limited partnership, limited liability partnership, and limited liability Companies must be in "Good Standing" with the State Department of Assessments and Taxation.

Please type or print in ink the application. Illegible applications will not be accepted.

FALSE, OMITTED OR MISLEADING INFORMATION PROVIDED IN THIS APPLICATION WILL CONSTITUTE GROUNDS FOR DENYING A LICENSE OR VOIDING AN ISSUED LICENSE.

Checklist For Wholesaler's Paper Gaming License Application:

- Application form complete and accurate.
- Attach copy of business license.
- Notarized PAPER GAMING LICENSE APPLICATION PRIOR RECORD AFFIDAVIT(S) for each owner and/or corporate officer attached.
- Copy of driver's license for each owner and/or corporate officer attached.
- Signed WHOLESALER'S PAPER GAMING LICENSE APPLICATION STATEMENT attached.
- Social Security Number for each owner and/or corporate officer.
- Evidence that all taxes have been paid.
- Fee paid.
- Bond attached.
- Copy of paid personal property bill.
- Be in "Good Standing" where applicable.
