BEER, WINE, AND LIQUOR TASTING PERMIT REGULATIONS

1. A Beer, Wine, and Liquor Tasting Permit can be issued to any class of license with the privilege to sell beer, wine, and liquor.
2. There is a one-time issuing fee of \$150.
3. The annual fee is \$150 in addition to the annual renewal fee of the class of license.
4. Application shall be made on forms supplied by the Allegany County Liquor Board. Renewals may be made at the time the regular license is renewed. A permit may be granted without a public hearing; however, if the application is denied, the applicant may request a public hearing before the Board of License Commissioners.
5. Sample sizes:

BEER

Maximum of 2 ounces per brand, maximum of ten (10) ounces per person.

WINE

Maximum of 1 ounce per brand, maximum of five (5) samples per person.

LIQUOR

Maximum of ½ ounce per brand, maximum of three (3) samples per person.

6. The licensee shall notify the Allegany County Liquor Board in writing on the designated form at least 7 days before a tasting event is to be held.
7. Licensee(s), employee(s), promoter(s) shall not furnish beer, wine, or liquor for the purposes of tasting/sampling to any person who is under 21 years of age.
8. Licensee(s), employee(s), promoter(s) shall not furnish beer, wine, or liquor to any person who is visibly under the influence at the time of dispensing.
9. Beer, Wine, and Liquor Tasting permit is for on-premise consumption only. An open container may not be carried from the premises to be consumed elsewhere.
10. Sampling/Tasting may NOT be done from a drive-through window.
11. There are an unlimited number of tasting events permitted during each licensing period (May 1 thru April 30)
12. The contents of each bottle may not be mixed with any other bottle and all bottles shall be destroyed once they are empty.
